30 March 2017 deadline for 'reserved' names

Following a public consultation run between May and June this year, the Operations and Procedures policy has been amended to clarify that reserved .nz names need to be registered by 30 March 2017.

A 'reserved' name is a domain name direct at the second level that eligible registrants had consciously reserved for their own future registration. The ability to reserve names was a key part of the policy change allowing names directly at .nz.

The option to reserve was offered between September 2014 and March 2015. Exercising the option to reserve gave eligible registrants who weren't sure whether they'd want or need their name direct at .nz time to consider. Now, registrants with a reserved name need to decide whether to go ahead with their registration or not.

The 30 March 2017 deadline for reserved names, now confirmed, gives those registrants approximately seven months from now to register their reserved name. Importantly, if a reserved name isn't registered by 30 March 2017, it will become available for anybody to register – on a first-come, first-served basis.

Later this year, DNCL will provide registrars with relevant communications material around reserved names they can use with their affected customers.
