Individual Registrant Privacy Option

The Individual Registrant Privacy Option was made available to registrars to start offering to registrants on 28 November 2017. Some have already begun offering the service, with more coming online between now and 28 March 2018 when it becomes a compulsory offering inline with policy. You can see which registrars are offering IRPO already at www.dnc.org.nz/registrars.
