Summary of the .nz market

As at 20 August 2003, 41 organisations had been authorised as .nz registrars. Of those, 30 had connected to the production SRS and were undertaking domain name registration and management directly with the SRS. With the Stabilising Registrar, Domainz, and the DNC Registrar there are 32 registrars on the SRS.

July saw the largest month for new domain name registrations, with 4,051 new domain names created during the month. Overall net growth for July was 2,129 as there were a high number of cancelled domain names also over the month. The total number of .nz domain names at the end of July was 132,056.

Implementation of the new second level domain - .geek.nz

Registrations in the .geek.nz second level domain name space are available from 11am on Tuesday 26 August. The InternetNZ Council approved the allocation of 'www.geek.nz' to the applicant of the proposal to create the new second level domain, Dean Pemberton. Aside from this domain name, all other .geek.nz domains are available on the standard first come, first served basis.

Domain Names NZ

A large number of .nz domain name registrants received a letter from a company trading under the name of Domain Names NZ and soliciting for new registrations in a domain that the registrant didn't currently have. This letter specified a particular domain name, based on a name already registered, and had the appearance of a renewal notice or invoice. The confusion caused by Domain Names NZ was widespread and resulted in a lot of calls to registrars, the Commerce Commission, Consumers' Institute, Fair Go and the Office of the DNC.

It appears that a variety of different alternatives were offered by Domain Names NZ. The most common appeared to be registrants of .co.nz domain names receiving a letter with the .net.nz version of their domain detailed. There were, however, also .com registrants being 'offered' .co.nz names, and other .nz registrants being offered .com or .net domains.

Notices were issued by a number of registrars and ISPs. The DNC also put out a public notice, as did the Commerce Commission. The DNC is still working with the Commerce Commission on possible outcomes from this. The organisation involved is based in Australia and are already known to the .au Domain Administration (auDA). The DNC acknowledges the assistance of the CEO of auDA, Chris Disspain, in working through this matter.

Domain Name Allocation process ends 5 September

InternetNZ has announced the sale of Domainz to Melbourne IT. The settlement of the sale is due to occur on Friday 5 September 2003. From this date the Domain Name Allocation policy no longer applies. Any registrar wanting to transfer bulk domain names after this date will need to use the bulk transfer process in the Transfer to Another Registrar policy (http://dnc.org.nz/content/transfer registrar.pdf)

Email out to registrants

The final batches of emails out to registrants, informing them of the competitive market and asking them to select a registrar, have been done. The final date for registrants to go onto the DNC site and select a registrar is Wednesday 3 September. The draw for the trip to Fiji will take place shortly after and the winner will be published in the September newsletter.

Final statistics from the email out will also be in the September newsletter. To date, the response rate has been around 16%, with around 57% of those responding selecting Domainz.

The increase in the number of whois queries was nearly all through the whois server. The queries were undertaken in a manner that triggered the initial rate limiting checks on the whois server. After that limit was breached however, the servers' volume decreased to fit it under the rate limiting steps. From investigations by NZRS it appears as though over 300 different IP addresses contributed significant hits to the .nz whois, each at levels below those that trigger the alerts. There has been more than one IP number blacklisted from accessing the whois.

With the mass mail campaign undertaken by Domain Names NZ in early August, it would appear that this attack on the .nz whois was the source for some of the information used.

Daily monitoring has now been put in place for the whois. In addition to rate limiting checks, there are also other parameters set and these will either lead to IP addresses being blocked from access, or will trigger an alarm to NZRS who can then investigate who has accessed the whois and why. These measures should make the protection of the .nz register more robust.
