#### Vikram Kumar resigns from InternetNZ

For those of you who don't know, both the DNC and NZRS are subsidiaries of InternetNZ, a non-profit incorporated society. InternetNZ is New Zealand's leading Internet advocacy organization. Their vision is "an open and uncaptureable Internet".

This month Vikram Kumar announced that he would be leaving InternetNZ, after leading the organisation through three years of major change.

## 2012-13 was the second best year for .nz domain name growth in the last five years

From January 1, 2012, to January 1, 2013, .nz domain names have grown 10.20%. This is up from 10% the year before. The best year of growth in the last five years was 2010-2011, where .nz domain names grew 10.81%.

Domain Name Commissioner Debbie Monahan says this growth is likely to be a reflection of more people going online and the increased trust people have for .nz domain name endings.

"A lot of the reason why .nz is growing is because of the work registrars do promoting it. This is great to see and I hope we'll continue to see growth as time goes on," she says.

#### Why report all these statistics?

For regular readers of this newsletter, the monthly reporting of facts and figures may seem excessive. However, transparency about how the registry is both being managed and is performing has been an important part of our culture since the beginning. In fact, reporting these monthly statistics is part of the Service Level Agreement that exists between the NZRS and DNC. These agreements are also regularly reviewed so as to ensure best practice methods are being used.

Ultimately, the SLA states that the NZRS must regularly report on:

- Registry availability and outages
- The registration and cancellations of domain names
- Registry response times
- Zone pushes
- Denial of Service Attacks.

Under the agreement, the DNC can also assess the NZRS's performance by auditing:

- Server security (both physical and network security)
- Server host logs
- Capacity plans.

#### Time for your annual WHOIS check-up?

Just like visiting the doctor or dentist once a year isn't a bad idea, neither is checking your WHOIS information. A simple check of any website you have – or one you're registering for a client – can save you time, money and aggravation in the long run.

For registrars: If you become aware that the contact details for a .nz domain name may be wrong, then you are obliged to chase up your customers to correct any inaccurate information displayed in the register. The registrant's contact details do not necessarily need to be a residential address, but they must enable contact.

For registrants: If your contact details on the WHOIS page are incorrect, please tell your registrar to update the information.

For the general public: If you see incorrect details on someone else's domain name, please inform the registrar. If they are unable to reach the domain name holder we will look into the matter once we are informed. Correct details are important because, in some situations, when a registrant is unable to be contacted we will cancel the domain name.

#### How to check your details

Visit <a href="www.dnc.org.nz">www.dnc.org.nz</a> and use the 'search domains' tool on the top left-hand corner of the page. Your details should show as the Registrant Contacts. It is important that you check that you still have access to the e-mail address listed on the record. This is the address that your registrar will use to communicate with you about the registration, so it is critical that you receive these messages.

### **Statistics**

In December, the number of active .NZ domain names increased from 515,987 to 517,037, a net increase of 1050.
