Last call for Kiwis to speak up on proposed changes to the .nz domain name space

Only one day remains for New Zealanders to voice their opinions on proposed changes to New Zealand's Domain Name System (DNS).

The Domain Name Commission Limited's (DNCL) proposal, which is in its second round of consultation, puts forward the idea of opening domain name registrations directly at the second level.

Should the proposal go forward, this means that people who want to register, say, anyname.co.nz might one day be able to simply register anyname.nz. You will note that the '.co' portion is no longer included. This would mean that second level domains like .ac, .co, .geek, .gen, .kiwi, .māori, .net, .org and .school might no longer be required, though people could still opt for them if they wanted to.

Domain Name Commissioner Debbie Monahan urges New Zealanders to weigh up the pros and cons of the issue and to alert the DNCL of their views through the submission process.

"It's possible that allowing registrations directly at the second level could cause confusion in the short-term. However, it could also improve the .nz domain name space in the long-term," she says.

"One advantage of the change is that people would no longer have to choose a second level domain that they did not identify with it. There is no technical reason for second levels to have to exist and this proposal would offer more consumer choice.

"However, we also acknowledge that existing domain name holders might feel as though they have to register their domain names at both second and third levels, for example getting both anyname.co.nz and anyname.nz."

DNCL encourages New Zealanders to consider these issues carefully and voice their views through the submission process. The greater range of quality opinions DNCL receives, the better. The cut-off date for submissions is midday Wednesday 31 July, 2013.

Technical fix leads to seventeen domain names being cancelled

NZRS recently discovered that it has been possible to register Internationalized Domain Names (IDNs) that did not conform to policies on acceptable characters.

As a result, 17 impermissible Unicode characters were registered, one of which was used by NZRS to check the issue.

An analysis of the 16 other names showed that they were registered through the same registrar and reseller and contact was made with those parties. These domain names have now all been cancelled.

The structure of permissible .nz domain names are outlined in section 4.2 of DNCL's 'Registering, Managing & Cancelling Domain Names' policy (http://dnc.org.nz/content/registering managing cancelling.pdf).

The DNCL Board has written to the NZRS Board in relation to the process issue at the registry that resulted in the names being registered contrary to .nz policy.

Whilst DNCL is satisfied at an operational level that the root cause was identified and remedied to prevent any such failures in the future, DNCL is seeking confirmation that the NZRS Board is confident all the issues have been appropriately addressed.

DNCL has also requested a review of the IDN implementation be undertaken and reported to DNCL so that there can be confidence in the technical solution around .nz IDNs.
