#### **Consultation on Second Level Domains Policy Review**

InternetNZ, through Domain Name Commission Limited (DNC), is currently reviewing the existing Second Level Domains (2LD) policy. The current policy can be seen at <a href="http://dnc.org.nz/content/second-level-domains.pdf">http://dnc.org.nz/content/second-level-domains.pdf</a>

This policy was last reviewed over 2003-2004 when a Working Group put out papers for public consultation. These papers sought comment on a number of issues including introducing registrations in .nz at the second level and the process for creating a new second level domain. The review resulted in changes to the process of creating a new second level domain but did not introduce .nz registrations at the second level.

Since that last review, three new second level domains have been added to the .nz space - .bank.nz, .parliament.nz and .health.nz. All three new second level domains are moderated ones. There have been no new open 2LDs since .geek.nz back in 2003, under the previous policy.

The 2LD Policy sets out the general rules regarding the structure of the .nz domain name space. Appendices to the policy provide the application forms for new 2LDs and a schedule of fees.

### Currently the policy includes:

- The list of open and moderated second level domains, defining the communities of interest reflected in the .nz 2LD structure
- The criteria for new 2LDs and the process undertaken upon application for a new open or moderated second level domain
- The procedure for closing an existing 2LD

### Internationalised Domain Names (IDN) project – 'IDN Friendly Status'

The DNC office is currently working through the various requirements needed as we get closer to the launch of IDN registrations in the .nz space.

One of the aspects of the implementation of IDNs in .nz is the implementation of an 'IDN Friendly Status' tag for .nz authorised Registrars. This idea was put forward by Registrars at the Registrar Advisory Group (RAG) meeting in September last year.

Some criteria mentioned at the RAG meeting included using macronised characters in all forms of communications with registrants and providing links the Māori keyboard software.

We welcome all suggestions and feedback on what could be involved with the IDN friendly status. If you have any thoughts on what this status could consist of please send them into us via info@dnc.org.nz.

This month saw the completion of a major upgrade of the SRS and DNS infrastructure. The hardware and operating system at our primary site in Albany has been successfully updated. In the first few days of running on the new platform, the performance of the SRS is showing signs of improvement in the transaction response times. The full impact of the upgrade should be seen in the response time statistics published next month.

The implementation of IDN compatibility within the SRS is well underway. A 'beta version' of the IDN code changes is available on the SRS RPS test system and Registrars should test their systems in this environment as soon as possible and no later than by the middle of February 2010.

# SRS Releases / Planned Scheduled Outages

SRS 3.06 was released in the maintenance window at the end of November. In this release we made a change to the validation rules for DNS 'Glue Records'. Previously if you needed 'Glue Records' you had to have IPv4 and/or IPv6 addresses. With this change two name servers are still required but you can have either IPv4 or IPv6 addresses or combination of the two.
