:: DNC OFFICE ::

In August, the number of active .nz domain names increased from 160,762 to 163,738, a net increase of 2,976. This is the second highest net increase over the past twelve months and the third highest net increase since the beginning of the SRS in October 2002.

Whois Working Group Meeting

The first Whois Working Group meeting was held in Wellington on Thursday 9 September. A paper is being prepared seeking public consultation, and raising some of the questions the Working Group is keen to address. It is likely consultation will take place in October.

Zone Transfer Policy

This is a final notice that the new Zone Transfer Policy comes into effect on Friday 1 October 2004. It will be posted on the Policies and Procedures page of the DNC website (http://dnc.org.nz/policies) on that date.

Change of Directors and Shareholders

Authorised registrars are reminded that under Clause 23 of the Authorisation Agreement, you are required to notify the DNC if there is a proposed change to your ownership, management or control. This includes changes in directors or significant shareholders. Registrars need to seek consent to the Authorisation Agreement continuing where such a change is to take place. Any such notifications will be treated strictly confidentially by the DNC.


Market Share Information



Graphs have been produced which show the market share of .nz registrars in three groups: the top four registrars, the next four registrars and the remaining registrars. In addition a table of the monthly market share information is also available.

The market share information has been published up until August 2004 and dates back to March 2003, when the .nz domain name market was declared competitive. In future the market share information will be published every month at the same time as the .nz statistics.

Two graphs, from March 2003 and August 2004, have been copied below. They illustrate the change in the composition of the market over this time.
